We recognise the moral and legal obligations of mandatory reporting and educate all staff in this expectation.

Our selection and induction processes of new employees includes child safety criteria.

Our existing staff are reminded of their role in maintaining a safe environment for all clients, including children.

We are committed to safety and wellbeing of all clients, including children. Our employees accept the Code of Conduct expectations in respect tochild safety.

We respect the cultural and linguistic diversity of all clients.

### **Background**

In 2012, the Victorian Government initiated an inquiry into the handling of child abuse allegations within religious and other non-government organisations, the Inquiry into the Handling of Child Abuse by Religious and Other Organisations.

Report: Betrayal of Trust (2014) Victorian Government listed a range of recommendations, including the need

to better protect children when they access services provided by these organisations. As a result the Child Safe Standards and Reportable Conduct Scheme create distinct sets of responsibilities for preventing, and in turn report allegations of child abuse of clients within our organisation.

The Victorian Inquiry has resulted in new legislation for the state.

# 7 Standards

- 1. Provide a child safe awareness and culture with in CCC
- 2. Code of Conduct
- 3. Clear policies and procedures
- 4. Recruitment and selection processes
- 5. Clear processes of reporting suspected client/ child abuse
- 6. Risk management
- 7. Empowerment of children





In summary, the three criminal offences of:

- Grooming; which is predatory conduct undertaken to prepare a child for sexual activity at a later time;
- Adults' failure to report criminal child abuse to the police; and
- Failure by those with responsibility with in an organisation to remove or reduce a substantial risk that a child maybe sexually abused.

#### **Definitions**

'Child' refers to anyone under the age of 18 years. 'Abuse' refers to both adult to child abuse and child to child abuse. Abuse and neglect includes but is not limited to:

- Physical abuse when a person purposely injures or threatens to injure a child or young person.
- Emotional abuse an attack on a child or young person's self-esteem such as bullying, name calling, threatening, ridiculing, harassing, intimidating or isolating the child or young person.
- Family violence when a family member, partner or ex-partner attempts to physically or psychologically dominate the other.
- Sexual abuse any sexual act or sexual threat imposed on a child.
- Grooming predatory conduct undertaken to prepare a child for sexual activity.
- Neglect where a child is harmed by the failure to provide the basic physical and emotional necessities.
